**Re: Notice of merger by incorporation of Butler Engineering and Marketing S.p.A., Space S.r.l. and Ravaglioli S.p.A. into Officine Meccaniche Sirio S.r.l. and simultaneous renaming of the company to Vehicle Service Group Italy S.r.l.**

We hereby inform you that:

- by deed of Notary Diego Apostolo dated June 22nd, 2023 Repertory No. 3734 - Collection No. 3062; and
- by deed of Notary Diego Apostolo dated June 22nd, 2023 Repertory No. 3735 - Collection No. 3063, both having legal effect as of **July 1<sup>st</sup>, 2023**,

the merger by incorporation of the following companies took place:

- Butler Engineering and Marketing S.p.A.**, with registered office at Via dell'Ecologia No. 6 – 42047 Rolo (RE), VAT No. 01741580359, tax code and registration number with the Companies Register of Reggio Emilia 01824810368,
- Space S.r.l.**, with registered office at Via Sangano No. 48 - 10090 Trana (TO), VAT number, tax code and registration number with the Company Register of Turin 07380730015, and

At the same time, Officine Meccaniche Sirio S.r.l. changed its corporate name to **Vehicle Service Group Italy S.r.l.**

The incorporating company assumes all the rights and obligations of the merged companies, Butler Engineering and Marketing S.p.A., Space S.r.l. and Ravaglioli S.p.A., continuing in all their legal relationships, assets and liabilities, prior to the merger.

As a result of this merger and pursuant to EU Regulation No. 679/2016 (“GDPR”) and Legislative Decree 196/2003, as amended by Legislative Decree 101/2018 (“Privacy Code”), the company **Vehicle Service Group Italy S.r.l.** also takes over ownership of the personal data already processed by the merged companies. However, the purposes and methods of data processing as communicated with the notices pursuant to art. 13 GDPR of the merged companies remain unchanged, as per the new notice pursuant to art. 13 GDPR of Vehicle Service Group Italy S.r.l., available on current and future company websites.

Following the legal effects of the aforesaid merger by incorporation, only the company **Vehicle Service Group Italy S.r.l.** will be operative, to which reference must be made for any business relationship, even if arising prior to that date.
